There are a number of ways we can use your help:

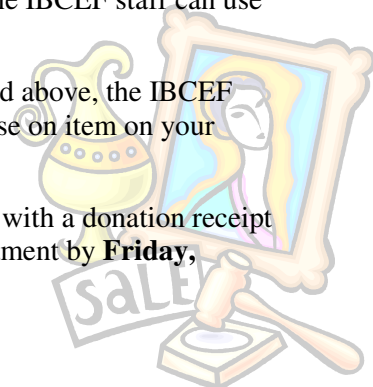
